**CONSENT MOTION TO CONTINUE DECEMBER 5, 2022 STATUS  
CONFERENCE AND TO EXCLUDE TIME UNDER THE SPEEDY TRIAL ACT**

Defendant Matthew Purdy, through undersigned counsel, respectfully files this *consent* motion to continue the status conference in the above-captioned matter presently scheduled for December 5, 2022, at 11:00 am. The Purdy Defendants’ mother passed this week and the family is in bereavement, with family services and burial preparation for their mother in conflict with the presently scheduled status conference. This is also a conflict for Defendant Turner, as he is the brother of the Purdy Defendants’ mother. The parties have conferred, and all Defendants seek a continuance of the upcoming status conference and the Government consents to the requested continuance. The Defendants also agree to the exclusion of time under the speedy trial act from December 5, 2022, until the next status conference scheduled in this matter as it will provide the Defendants additional time to confer with their counsel regarding a potential resolution of this matter in lieu of trial.<sup>1</sup> Accordingly, the parties agree that the “the ends of justice served by the granting of such continuance [will] outweigh the best interests of the public

and the defendant in a speedy trial,” 18 U.S.C. § 3161(h)(7)(A), and the parties request an order to that end.

By the filing of this motion, undersigned counsel represents that the United States and counsel for Defendants consent to the relief sought in this motion.
