This document is being written to share with you my back ground with Mr. Luke Faulkner. Sixteen years ago my son and I were in the process of general contracting a new home for my daughter and her first born son who was diagnosed with Duchenne Muscular dystrophy, which is a terminal disease. We were told by my grandson's doctor that his life expectancy was fifteen to possibly twenty years of age. We had reached the point of the construction that we were ready to pour the concrete for the basement floor and the walkways and driveways around the house. Luke Faulkner happened by our building site and stopped to introduce himself and asked if we had a bid yet for that work. I told him we did and he asked if I would be interested in him giving us estimate for doing this work. While we were talking he inquired about my reasons for building this house and I explained to him that I wasn't a builder by trade but rather a grandfather who wanted his grandson to have a wheelchair accessible home. When Luke heard this information he called the local cement company that he orders all his cement from and told them this story and they cut the cost of my building expense by 33%. Even after his part of the building process was complete he would routinely stop by the house to see how we were doing and would often make helpful recommendations. For years after that Luke would call to see how I was doing and how my grandson was also doing. My daughter invited Luke to the house when it was complete to thank him for his help in saving significant money for us and to have him meet my grandson Brody. In recent years on two different occasions I have used Luke for concrete related work and he is still as genuine and caring as always. No other contractor ever called or cared to follow up on Brody's health. This is a man of good character and someone I have the highest regards for.
