INTRODUCTION:

On 01/01/2019 at approximately 0157 hours I Ofc. B. Barnard was dispatched to 3907 Ave J in reference to a disturbance involving a male and female.

DETAILS:

Upon arrival I made contact with [REDACTED] (TX DL#: [REDACTED]) who advised her ex-boyfriend Brian Jackson (TX DL#: [REDACTED]) slammed her head into the ground. Both Brian and Robin were extremely intoxicated. Robin had a lot of what appeared to be blood on the front of her shirt as well as on her neck. I observed Robin to have a large amount of blood in her hair coming from a cut where she advised her head was slammed on the ground. Brian advised he did not touch Robin and there was nothing physical between them other than Robin hit him in the lip and bit him. I advised Brian of Robin's injuries and he advised he had no idea where they came from. Due to Robin's statement and the injuries she sustained which corroborated her story Brian was subsequently placed into custody for Assault Causing Bodily Injury Family Violence (ACBI F/V) M-A.

I brought Brian to the rear of my patrol vehicle and instructed him to get into the vehicle at which point he began yelling at Robin. I again commanded Brian to get into the vehicle which he refused again still yelling at Robin. I assisted Brian into the vehicle at which point Brian started yelling, " Don't put your hands on me mother fucker". Brian was allowed to get out of the vehicle so he could adjust himself into a more comfortable position and he once again began yelling at Robin. I advised Brian three more times to get into the car or he would be placed into the vehicle. Brian ignored my commands and had to be physically placed into the vehicle at which time he actively and physically resisted being placed into the vehicle. Brian then drew his leg back as if he was going to kick Ofc. Danesi and was quickly advised of his actions at which time he put his leg down. Brian is now being charged with Resisting Arrest Search or Transport (M-A). Robin was issued a Notice to Adult Victims of Family Violence form. Robin was placed into custody for Assault By Contact F/V and was later released on a PR Bond. Brian was also issued a Notice to Adult Victims of Family Violence Form.
