TODD S TILLEY is entitled to monthly disability benefits beginning July 2022.

We have chosen you to be his representative payee. Therefore, you will receive his checks and use the money for his needs.

**The Date You Became Disabled**

We found that TODD S TILLEY became disabled under our rules on January 11, 2022.

To qualify for disability benefits, TODD S TILLEY must be disabled for five full calendar months in a row. The first month he is entitled to benefits is July 2022.

**What We Will Pay And When**

- You will receive \$1,467.00 for October 2022 around November 9, 2022.
- After that you will receive \$1,467.00 on or about the second Wednesday of each month.

**Other Government Payments Affect Benefits**

We are withholding his Social Security benefits for July 2022 through September 2022. We may have to reduce these benefits if he received Supplemental Security Income (SSI) for this period. When we decide whether or not we will have to reduce his Social Security benefits, we will send him another letter. We will pay him any Social Security benefits he is due for this period.

**Other Social Security Benefits**

This benefit is the only benefit he can receive from us at this time. In the future, if you think he might qualify for another benefit from us, he will need to apply again.

## Your Responsibilities

We based our decision on information you gave us. If this information changes, it could affect his benefits. For this reason, it is important that you report changes to us right away.

We have enclosed a pamphlet, "What You Need To Know When You Get Social Security Disability Benefits." It tells you what you must report and how to report. Please be sure to read the parts of the pamphlet that tell you what to do if he goes to work or his health improves.

A vocational rehabilitation or employment services provider may contact TODD S TILLEY to help him in going to work. The provider may be from a State agency or work under contract with Social Security.

If goes to work, we have special rules that let us continue his cash payments and health care coverage. To learn more about how work and earnings affect disability benefits please contact us. ## Your Benefits May Be Taxed

You may have to pay taxes on the benefits you get from us. Part of your Social Security benefits may be taxed if:

- you are single and your total income is more than \$25,000 or
- you are married and you and your spouse have total income of more than \$32,000.

You can decide if you want to have federal taxes withheld from your benefits. If you want taxes withheld, you need to complete and return a Form W-4V, Voluntary Withholding Request. You can get Form W-4V from the Internal Revenue Service by calling 1-800-829-3676. You can also get this form at [www.socialsecurity.gov/planners/taxes.htm](http://www.socialsecurity.gov/planners/taxes.htm) on our website. After you complete and sign the form, return it to your local Social Security office by mail or in person.
