**CONSENT MOTION TO CONTINUE STATUS CONFERENCE AND EXCLUDE TIME
UNDER THE SPEEDY TRIAL ACT**

The United States, through undersigned counsel, hereby files this motion to adjourn the status conference set for Thursday, March 23, 2023, in the above-captioned matter until Thursday, April 13, 2023. Counsel for defendant concurs in this motion. Counsel for defendant is currently in trial before Judge Mehta. Counsel for defendant further advised that he continues to review pre-indictment discovery productions. Additionally, plea negotiations have been productive, and it is anticipated that plea documents will be signed and filed prior to the next status conference.

The parties request that the Court exclude the time from March 23, 2023, until the next status conference, pursuant to 18 U.S.C. § 3161 *et seq.*, on the basis that the ends of justice served by taking such actions outweigh the best interest of the public and the defendants in a speedy trial pursuant to the factors described in 18 U.S.C. § 3161(h)(7)(A).
