GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:									

I am a duly sworn Special Agent with the Department of Justice, U.S. Attorney's Office - D.C., Criminal Investigations and Intelligence Unit, and have been a sworn federal agent since 2016. Prior to 2016, I was a sworn law enforcement officer in Maryland. During my law enforcement tenure I have been trained and participated in investigations involving criminal violations. I have conducted numerous arrests, executed federal search warrants, state search warrants, and also court orders. As such, I have gained both knowledge and experience in gathering and collecting evidence related to violations of Title 18 of the United States Code and other violations of federal law.

The U.S. Capitol is secured 24 hours a day by U.S. Capitol Police. Only authorized people with appropriate identification are allowed access inside the U.S. Capitol. Restrictions around the U.S. Capitol include permanent and temporary security barriers and posts manned by U.S. Capitol Police. On January 6, 2021, permanent and temporary security barriers were in place to separate areas where lawful first amendment activity could be conducted from areas restricted both to prevent any adverse impact on the legislative process and to safeguard and prevent any property damage directed at the U.S. Capitol and West Front Inaugural Platform. These security barriers included bike racks that were positioned to the north of the U.S. Capitol along Constitution Avenue; to the south of the U.S. Capitol along Independence Avenue; to the west of the U.S. Capitol along First Street on the eastern side of that street; and, on the east side of the U.S. Capitol, between the Capitol Plaza (East Front) and the grassy areas

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:																													

located between the Plaza and First Street. This bounded area is hereinafter referred to as the "Restricted Grounds." Within the West Front of the Restricted Grounds there were additional temporary barriers due to preparations and ongoing construction for the Inauguration including green snow fencing and signage stating "Area Closed By order of the United States Capitol Police Board." The exterior plaza of the U.S. Capitol was also closed to members of the public.

On January 6, 2021, a joint session of the United States Congress convened at the United States Capitol, which is located at East Street, SE, in Washington, D.C. During the joint session, elected members of the United States House of Representatives and the United States Senate were meeting in separate chambers of the United States Capitol to certify the vote count of the Electoral College of the 2020 Presidential Election, which had taken place on November 3, 2020. The joint session began at approximately 1:00 p.m. Shortly thereafter, by approximately 1:30 p.m., the House and Senate adjourned to separate chambers to resolve a particular objection. Vice President Mike Pence was present and presiding, first in the joint session, and then in the Senate chamber.

As the proceedings commenced, a large crowd gathered outside the U.S. Capitol. As noted above, temporary and restricted areas were in place around the exterior of the U.S. Capitol building, and

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:										

U.S. Capitol Police were present and attempting to keep the crowd away from the Capitol building and the proceedings underway inside.

At such time, the certification proceedings were still underway and the exterior doors and windows of the U.S. Capitol were locked or otherwise secured. Members of the U.S. Capitol Police attempted to maintain order and keep unauthorized individuals who had formed a crowd from entering the U.S. Capitol unauthorized individuals to stay out of the building and out of the designated restricted the Capitol building. U.S. Capitol Police also attempted to keep unauthorized individuals from entering the prohibited areas around the U.S. Capitol designated by permanent and temporary barriers and posts. Shortly after 2:00 p.m., however, individuals in the crowd forced entry into the U.S. Capitol, including by breaking windows and by assaulting members of the U.S. Capitol Police, as others in the crowd encouraged and assisted those acts.

Shortly thereafter, at approximately 2:20 p.m. members of the United States House of Representatives and United States Senate, including the President of the Senate, Vice President Mike Pence, were instructed to—and did—evacuate the chambers. Accordingly, the joint session of the United States Congress was effectively suspended until shortly after 8:00 p.m.

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:																													

During national news coverage of the aforementioned events, video footage which appeared to be captured on mobile devices and cameras of persons present on the scene depicted evidence of violations of local and federal law, including scores of individuals inside the U.S. Capitol building and the Restricted Grounds without any authorization.

On January 18, 2021, Supervisory Special Agent Bryan Molnar, United States Attorney's Office-DC Criminal Investigations and Intelligence Unit, received information from MPD Det. Matthew Batko regarding Micki Larson-Olson (hereafter S-1) who was present for the January 6, 2021 U.S. Capitol Grounds incident. Det. Batko provided a MPD Cobalt report in which MPD officers made contact with S-1 in regards to a call for a suspicious person and associated vehicle. The arriving officers identified S-1 and her vehicle (red two-door Mazda bearing Texas Registration QP8RIOT). Det. Batko provided the Cobalt report and associated images that the officers had located on S-1's social media page.

Supervisory Special Agent Molnar located and viewed S-1's Facebook account (titled: Micki Larson). S-1's profile picture showed S-1 wearing a red, white and blue spandex style bodysuit, thigh high red boots and was waving two large flags, one flag with a "Q" on it and another "Troops for Trump" flag. This picture was taken while S-1 was standing on top of a platform on top of the temporary scaffolding on U.S. Capitol grounds. See Photo Below:

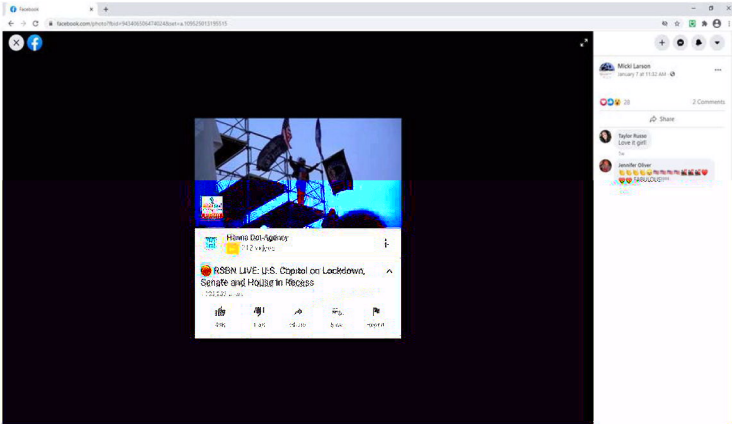

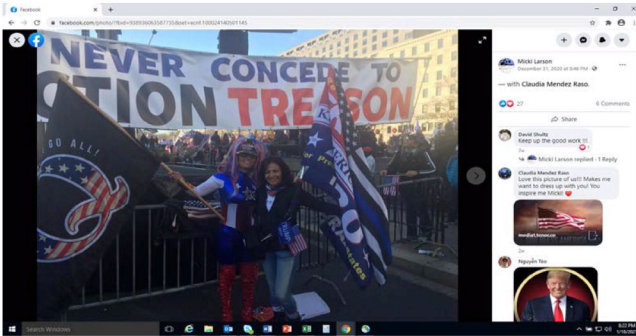

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:																													

On January 19, 2021, Special Agents Mark Fitzgerald and Sean Ricardi, United States Attorney's Office-DC Criminal Investigations and Intelligence Unit traveled to 811 Q Street, NW, Washington DC. Upon knocking on the door a female answered and the agents asked if S-1 was there. The female who answered the door led the agents upstairs to an interior door that had the number 23 on it. Agents determined that rooms in that residence were rented on Airbnb. S-1 stated she wanted to speak outside as to not bother other residents in the house.

S-1 and Agent Ricardi sat outside of the residence at a table that was adjacent to the sidewalk. Agent Fitzgerald stood next to Agent Ricardi. S-1 was also accompanied by Basil Gibbs. Mr. Gibbs informed the agents he was recording the encounter and Agent Fitzgerald informed them that he was recording the encounter also.

S-1 was asked about the events that occurred on January 6, 2021. S-1 said she was initially at the Ellipse then she walked to the U.S. Capitol. S-1 said she was on the lawn at the U.S. Capitol then she climbed scaffolding, which was in the restricted grounds area at the U.S. Capitol.

S-1 told agents that it took six police officers to get her off of the scaffolding. S-1 said she was holding onto the scaffolding while the officers were trying to get her down. S-1 said the officers

eventually got her off of the scaffolding and a female officer spoke about spraying her with pepper spray. While on the U.S. Capitol Grounds, S-1 was told by the officers to stand up, but she said she did not do so. S-1 said she did not comply with their directions to stand so the officers dragged her on the ground away from the scaffolding and then left her there. S-1 said the officers did not ask her for her name that day.

In viewing S-1's Facebook page, S-1 wrote on her Facebook page at 11:14 pm on January 6, 2020, "I am so sorry for everyone worried about me. I have a cheap tracphone and had no internet service. I have NEVER felt BRAVER, STRONGER IN MY WHOLE LIFE. I GOT TEAR GASSED AND STOOD BACK UP ON A BALCONY SHOWING MY Q FLAG and a Troops for Trump flag. I walked all over in my high heeled boots. I got dragged through the grass by 2 cops, that did that twice and told me to stand and I said no. I need my back pack and they wouldn't let me get it, but they finally gave up and the Captain let me get it. I gave him my WE'RE READY TO FIGHT POEM. I GOT CARRIED DOWN MANY FLIGHTS OF STAIRS BY COPS AFTER getting tear GASSED. It's all good. I will be back tomorrow."
