CONSENT MOTION TO CONTINUE STATUS CONFERENCE

The parties in the above-captioned action, by and through counsel, hereby moves with consent to continue the upcoming status conference forty-five (45) days. As grounds for this Motion, the parties state as follows:

1. On March 23, 2023, this Court set a scheduling conference for May 2, 2023.
2. Attorney Norman Pattis, herein after “the undersigned”, counsel for Defendant Douglas Wyatt, is on trial in the matter of *USA v. Ethan Nordean, et al.* (1:21-cr-00175-TJK) and has been since Jury selection began on December 19, 2022.
3. The case has since gone to the jury, and the undersigned is awaiting a verdict.
4. Given the complexity and sheer length of the trial, the undersigned believes it is not likely the jury returns a verdict prior to May 2.
