MINUTE ORDER granting the government's [23] Unopposed Motion to Strike Portions of the Indictment. Counts 3, 4, and 5 of the [14] Indictment charge the defendant with violating 18 U.S.C. ♦ 1752, which prohibits unlawful entry into a restricted building or grounds, defined as "any posted, cordoned off, or otherwise restricted area of a building or grounds where the President or other person protected by the Secret Service is or will be temporarily visiting." 18 U.S.C. ♦ 1752(c)(1)(B). Both the Vice President and Vice President-elect qualify as another person protected by the Secret Service. Id. ♦ 3056(a)(1). A defendant violates the statute either by the Vice President or the Vice President-

elect being present in the building or on the grounds. Counts 3, 4, and 5 currently contain references to both Vice President and the Vice President-elect, so the indictment charges "the commission of any one offense in several ways." *United States v. Miller*, 471 U.S. 130, 136 (1985). The government now moves to strike references to the Vice President-elect, as it admits that she was not present at the Capitol during the time of the offense. Other courts have permitted the striking of certain language in an indictment when "the prosecution is simply 'narrowing' the scope of the charges" and "add[ing] nothing new to the grand jury's indictment," thus "constitut[ing] no impermissible broadening." *United States v. Quinn*, 401 F. Supp. 2d 80, 90 (D.D.C. 2005) (quoting *United States v. Holland*, 117 F.3d 589, 595 (D.C. Cir. 1997)). Accordingly, the Court will amend the charging language in Counts 3, 4, and 5 from "where the Vice President and Vice President-elect were temporarily visiting" to "where the Vice President was temporarily visiting."
