III. Other Disclosures

A. Evidence

1. Physical Evidence

At trial the government may seek to introduce the physical evidence that is described on the attached police reports and those items listed below. This evidence may include, if such evidence exists:

- photographs of the scene, evidence and your client
- Diagrams or maps of the location where the incident occurred
- Documentary evidence as listed above

2. Radio Run Information

The government believes that there may be recorded communications relevant to this case. The recording will be provided consistent with the government's obligations under the Jencks Act. Should we determine that we may use the recorded communications as evidence at trial, we will provide you a copy of the tape after we receive it.

3. Identification Evidence

The identification procedures are described in the Gerstein for this matter.

4. Inspection

Upon request, you are entitled to inspect and copy or photograph certain books, papers, documents, photographs, tangible objects, buildings or places that are within the possession, custody or control of the government. *See* Super. Ct. Crim. R. 16(a)(1)(C). If you would like to view any of the evidence listed above or described on the attached police reports, please contact me immediately and we can make arrangements for you, or your certified investigator, to inspect the evidence. These arrangements will include a condition that you not raise any objection to the admissibility of such evidence at trial because of the break in the chain-of-custody occasioned by your inspection.

B. Other Crimes Evidence

At this time, the government is unaware of any other crimes evidence, as defined by Drew v. United States, 331 F.2d 85 (D.C. Cir. 1964) and Toliver v. United States, 468 A.2d 958 (D.C. 1983) and their progeny, which we intend to introduce at trial. The government, however, reserves its right to introduce such evidence.

C. Defendant's Rule 16 Statements

Other than any statements contained in the police paperwork, Body Worn Camera footage, other recordings from January 6, and electronic evidence obtained via search warrant, the government is not aware of any discoverable statements made by your client to law enforcement officers. If the government becomes aware of any such statements, I will notify you in writing of the content and circumstances in which they were made.

D. Criminal Record

At this time the government is aware that your client may have impeachable criminal convictions. Please refer to the Pretrial Services Report that you received at arraignment for further information about your client's record. I will notify you in writing if the government learns of any additional convictions it intends to use at trial beyond those disclosed in that document.

E. Government's Discovery Requests

The government hereby makes the following discovery requests:

1. notice of documents and tangible objects the defendant expects to introduce pursuant to Super. Ct. Crim. R. 16(b);
2. a Jencks request for all prior statements of any defense witness (excluding the defendant) pursuant to Super. Ct. Crim. R. 26.2;
3. a Lewis request (for which we request the name, date of birth, sex, and social security number of each defense witness prior to trial); and
4. a request for information pertaining to any expert or scientific testimony or evidence pursuant to Rule 16(b)(1)(B) and (C).

Pursuant to Super. Ct. Crim. R. 16(b)(2), we note our continuing request to receive any material pursuant to Rule 16(b) as the case proceeds.

F. Alibi Demand

The government does not make an alibi demand pursuant to Super. Ct. Crim. R. 12.1.

G. Other Information (Brady/Lewis/Giglio)

The government is unaware of any Brady or Giglio information, but is aware of its continuing duty to disclose such information should it become known. Lewis information for the government's witnesses will be provided to you at the time of trial.
