## **NOTICE OF FILING**

At the last hearing for these matters on February 11, 2022, the court ordered that all defendants must file a notice on the docket by March 4, 2022, regarding whether or not the defendant is requesting a bench trial. By March 4, the government had received notices from only three defendants: Anthony Tammaro, Mauricio Mendez, and Victoria Bergeson. Defendant Earl Glosser filed his notice on March 9, 2022. Each of these defendants requested a bench trial.

On March 11, 2022, given that the government had only heard from four defendants, it emailed all defendants reminding them of the March 4 deadline and requesting that such notices be filed as soon as possible. Subsequently, counsel for John Parker replied via email with his request for a jury trial (noting that he had previously filed a jury request), counsel for Andrew Johnson filed a re-newed request for a jury trial (as he had also previously filed a jury request), and counsel for Joshua Knowles filed a request for a bench trial.

As a result, as of the date of this filing, defendants Anthony Tammaro, Mauricio Mendez, Victoria Bergeson, Earl Glosser, and Joshua Knowles have requested a bench trial. Defendants John Parker and Andrew Johnson requested a jury trial.

The following defendants have not filed on their respective dockets: Yevgemya Malimon, Kristina Malimon, David Ross, Jere Brower, David Fitzgerald, and William Leary. With the

exception of defendants Brower and Ross, however, each of these defendants have previously requested a jury trial.

Both Malimon defendants orally requested jury trials at multiple prior hearings, and also filed a written demand on February 11, 2022. Defendant Fitzgerald orally requested a jury trial at the September 13, 2021, status hearing. Defendant Leary previously filed a jury demand on February 13, 2022. As for defendants Brower and Ross, the government was unable to locate any prior filed notices or oral requests for either a bench or jury trial. As a result, the government has no information regarding defendant Brower's and Ross's intentions.

The government does not oppose a bench trial for any of the defendants that have requested a bench trial. While the government does not know the positions of defendants Brower and Ross, it does not oppose any future requests for a bench trial by them or any other defendant.
