I agreed to sell it to him instead of even advertising it and trying to get as much money as possible because I could see how much he wanted to have that for his children at his home. He already had the building for it, and it was a pleasure to sell it to someone knowing that it was going to make a difference in the lives of children. As the youngest child in a family of 10 children, I know the value of keeping good ethics and morals instilled in your children and I grew up playing outdoors and staying healthy, much like Zac 's children are doing. During his sessions Zac talked about his kids all the time and how much he loved to take them sailing, how smart they are etc. I don't think I ever heard him say an unkind word about anyone and I trained him for close to a year. He missed his mother horribly and that is another reason why I really respected him because we shared the loss of our mothers in common. I loved to see the look in his eyes when he spoke of her. Even though I did not meet Zac before I started training him, I played music at a music festival that he hosted at his home in Rogersville. He was busy working and I did not get the chance to meet him before or after I played my set. It was a very hot day and not a lot of people showed up and I know he lost a great deal of money paying all the musicians for their time and talents. Later when I met him and was training him, he told me that it was worth it to support local musicians.

When Zac asked me to write this letter of reference I did not hesitate. He is a very good person and I hope that this helps whoever reads it to know that about him. I hope that he brings his kids up here to Northern Wisconsin to visit because I think they would love to play in the snow or go kayaking or go fishing etc. I moved here to get away from the bigger city because of my Christian faith and the fact that so many bad things were happening in Springfield Missouri as far as crime and violence.
